Scrapping the old parade float: Under Committee Reports

FN Frank Pollak briefed there is still a question about what constitutes a quorum to vote on Assembly business in the area of funds for charitable activities.

Faithful Purser Colin Jorsch answered the question with *Laws and Rules Governing the Fourth*Degree of the With Amendments to and Including the Year 2017, Article VIII Assembly

Officers and Duties, Section 24, paragraph (k), sub-paragraph (ii):

"No moneys in excess of \$500.00 shall be paid or transferred from the treasury of any assembly (except such moneys as the assembly is called upon to regularly pay for its current expenses, demands of the Supreme Council, purposes approved by the Supreme Council or Board of Directors, or initiation fees due the District Master) unless by a two-thirds vote of the members present and voting at a regular meeting held subsequent to a regular meeting at which notice in writing of a resolution of intention to pay or transfer such money and the purposes and amount to be paid or transferred shall have been given and regularly read. Provided, however, that any assembly may, by by-law, properly approved, provide and maintain a fund for rendering mutual

- aid and assistance to its sick, disabled and needy members and their families and families of deceased members. Said by-laws to state the manner in which, and by whom, the said fund is to be expended."
- FN Frank Pollak briefed Faithful Pilot Gerry Lewis needs a wheelchair while he is recovering from the fall he suffered earlier this year. He suggested \$300.00. SK Michael Smith stated he can purchase wheelchair for less than this amount.
