FAIRNESS

What is fairness? It depends on who you ask. Some people would say fairness is everyone is the same. That line of thinking is very boring. If everyone is the same there would be no one to excel in their chosen profession; military, writing, mechanic/machinist, medicine, and a host of others. Everyone would be the same. Fortunately, people are allowed to excel. One such individual is the late Dr. Jonas Salk who discovered the polio vaccine. (History.com) Now back to the question, "what is fairness?" According to Webster's Dictionary fairness is, "free from bias, dishonesty, or injustice." (Braham, 1996) This definition is sage advice to follow. What documents or books expand on this definition? There are three of these that come to mind; the Declaration of Independence, the United States Constitution, and The Holy Bible.

Reviewing American history, Thomas Jefferson penned the *Declaration of Independence*. (Carnes & Garraty, 2003) This document declared the United States' independence from the British Empire. What does the *Declaration of Independence* have to do with fairness? There is one statement that sums it up, "We hold these truths to be self-evident – that all men are created equal; that they are endowed by their Creator with certain inalienable rights; that among these are life, liberty, and the pursuit of happiness." (Laidlaw, 1888) In this passage the origin of fairness or being equal comes from God, not men. It can be inferred that unfairness occurs when men lose sight of God as the source of fairness. When men try to enforce a human inspired sense of fairness events run amuck. An example is the former Soviet Union under the rule of Joseph Stalin. (Young, 2015) His sense of fairness was whatever benefitted the state and his power. He took God completely out of the picture. The result was countless people executed as the result of show trials or death of millions in the gulags. The indifference and unfairness to human life permeated the Soviet Union and was one of the factors of its demise in 1991.

The next document that expands on fairness is the *United States Constitution* particularly the first ten amendments also known as the *Bill of Rights*. (Carnes & Garraty, 2003) The Bill of Rights protects our rights from

the government and ensures men are fairly protected from government intrusion. The Founding Fathers fought the War of Independence because of the overreach of Parliament and the British Monarch. They wanted to make sure there are safe guards against these governmental incursions on the citizens' rights. Examples of fairness in the *Bill of Rights* are freedom of religion, freedom of the press, right to bear arms, and protection from unlawful search and seizure. These rights as the Founding Fathers knew come from God to men and not from the government. If men meddle with these rights events could lead to the negative utopia of the Soviet Union and fairness being defined by man and not God.

Christ provides mankind with the best definition of fairness in the Sermon on the Mount in the Gospel of St. Matthew. The Sermon on the Mount covers chapter 5, 6, and 7. The passage in question is chapter 7 verse 12, "Do to others whatever you would have them do to you. This is the law and the prophets." (USCCB, 1986) Sometime in the 18th century this passage became known as "The Golden Rule." If you treat people how you would like to be treated you will not go wrong and fairness will be achieved. One of the most egregious examples of the violation of The Golden Rule is the Holocaust perpetrated by the Nazis government of Adolf Hitler. (History.com, 2015) Hitler viewed the Jewish people as less than human and a danger to the "Aryan race." The next statement is my opinion. Hitler would not like to receive the same treatment he and his henchmen metered out the Jewish people of Nazis occupied Europe. Hitler devised his manmade concept of fairness that resulted in the death of 6 million Jews and other people he deemed not worthy of living.

What is fairness? Manmade concepts of fairness end in disaster. Examples from history are numerous. Two of them are the Soviet Union and the Nazis government of Adolf Hitler. In the Soviet Union a negative utopia emerged. Life was cheap and many perished in the purges of Joseph Stalin. HUMAN TRAFFICKING

Human trafficking is a modern day tragedy. Most nations have laws against this heinous criminal activity. Families are split apart. In many cases the victims become slaves and are treated no better than a pack animal or worse. Unfortunately, the most innocent among us suffer the most. Baby factories use surrogate mothers to furnish infertile couples with a baby. It sounds good on paper, but it is not. Human trafficking exists not only abroad, but also domestically. The first item for review is what is human trafficking?

By the very name "human trafficking" implies moving human beings from one place to another for an intended purpose. The United Nations Office on Drugs and Crime (UNODC) has a more precise definition:

Article 3, paragraph (a) of the Protocol to Prevent, Suppress and Punish Trafficking in Persons defines Trafficking in Persons as the recruitment, transportation, transfer, harbouring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation. Exploitation shall include, at a minimum, the exploitation of the prostitution of others or other forms of sexual exploitation, forced labour or services, slavery or practices similar to slavery, servitude or the removal of organs. (UNODC, 2015)

This definition address the sinister part of human trafficking. Victims are forced or deceived into becoming human merchandise to be exploited and cast aside when they are no longer useful. The victims are used for sexual exploitation, forced labor, organ harvesting, or whatever the twisted minds of their captors can devise. Since the victims are so brutalize why is it so difficult to bring the perpetrators to justice?

There are two major reasons why bringing human trafficking criminals to justice is so difficult. The first is it is difficult to get accurate numbers. (Zurita, 2014). Human trafficking, by the nature of this heinous activity, is a clandestine operation. The preferred method of the perpetrators is to operate under the cover of darkness and in

remote areas. This method reduces the likely hood of law enforcement or a bystander witnessing the perpetrators in the act. The remote areas also reduce the chance that the victims will try to flee due to their unfamiliarity with the local area. The second reason is fear. The perpetrators instill fear in their victims to prevent them from reporting what has happen to them or becoming witnesses for law enforcement. Victims fear bodily harm, retribution against family, or deportation to their home nation. Many victims have an innate fear of law enforcement due to institutional corruption in their home nation.

Is any nation immune from human trafficking? Unfortunately, the answer is no. Human trafficking is a problem in foreign countries and domestically in the United States. An example of a foreign nation is Turkey. (Zaman, 2006) Many women from the former Soviet Union were lured to Turkey with the promise of jobs. Once in Turkey the perpetrators confiscated the women's passports. After the passports are confiscated the women are legally prevented from leaving the country. The women are pressed into slave labor, the sex trade, or both. The United States is not immune from this problem. Long Island, NY is a problem area in the United States. (Mead, 2006) New York City is a major port of entry for commercial aircraft and maritime traffic. The sheer volume of people and cargo entering New York City overwhelms local law enforcement. It is difficult for law enforcement to closely scrutinize everyone and especially every cargo container entering the port. A particular problem in Long Island is Asian women being forced into the sex trade. As bad as it is with women forced into the sex trade it gets worse.

Human trafficking affects the most innocent among us, babies. Improvements in medical technology have caused an increase in surrogate motherhood. (Taylor, 2015) Infertile couples can hire an agency specializing in surrogate mothers. The surrogate mothers are generally from a third world nation. India is prime country. Donor material is provided by the infertile couple and/or through the agency. Doctors in India perform the procedure on the surrogate mother to implant fertilized embryos. What is not told to the infertile couple is multiple embryos are implanted into the surrogate mother. This procedure results in multiple births. The infertile couple receives their baby: male or female which ever one is requested. The other babies have an uncertain future. If the baby is desirable he or she is sold on the black market. If the baby is undesirable the surrogate mother may take care of the baby, the organs maybe harvested or the baby is "discarded" as undesirable. Undesirables are the sad result of these baby factories.

Human trafficking is a very heinous crime. The victims are subject to an unknown fate. The fate could be forced servitude, sex trade, body organs harvested, or something worse. The clandestine aspect of human trafficking makes estimating the number of victims difficult to estimate and to bring the perpetrators to justice. Fear instilled in the victims hampers law enforcement efforts to control human trafficking. No nation is immune from human trafficking, not even the United States. The worse aspect of human trafficking is it affects the most innocent among us, babies.
